IMPORTANT – CONDITIONS PRECEDENT TO LIABILITY

PROCEDURE IN THE EVENT OF LOSS OR DAMAGE FOR WHICH INSURERS MAY BE LIABLE

Survey and Claims Settlement : In the event of loss or damage which may involve a claim under this Insurance immediate notice of such loss or damage should be given to and a survey report obtained from the office or agent nominated above. In the event of any claim arising under this Insurance, request for a settlement should be made to the office or agent nominated above, who are authorized to adjust and settle claims on behalf of the Company.

Liability of Carriers, Bailees or other third parties : It is the duty of the Insured and their Agents, in all cases, to take such measures as may be reasonable for the purpose of averting or minimising a loss and to ensure that all rights against Carriers, Bailees or other third parties are properly preserved and exercised. In particular, the Insured or their Agents are required:

1. To claim immediately on the Carriers, Port Authorities or other Bailees for any missing packages.
2. In no circumstances, except under written protest, to give clean receipts where goods are in doubtful conditions.
3. When delivery is made by Container to ensure that the Container and its Seals are examined immediately by the responsible official. If Container is delivered damaged or with Seals broken or missing or with Seals other than as stated in the shipping documents to clause the delivery receipt accordingly and retain all defective or irregular seals for subsequent identification.
4. To apply immediately for survey by Carriers' or other Bailees' Representatives if any loss or damage be apparent and claim on the Carriers or other Bailees for any actual loss or damage found at such survey.
5. To give notice in writing to the Carriers or other Bailees within 3 days of delivery if the loss or damage was not apparent at the time of taking delivery.

NOTE

The Consignee or their Agents are recommended to make themselves familiar with the Regulations of the Port of Authorities at the port of discharge.

Any claim under this Insurance should be submitted without delay, accompanied by all correspondence with the Carrier and other parties regarding their liability.

FAILURE TO COMPLY WITH THESE INSTRUCTIONS MAY PREJUDICE ANY CLAIM UNDER THIS POLICY.

Documentation of Claims : To enable claims to be dealt with promptly, the Insured or their Agents are advised to submit all available supporting documents without delay including where applicable:

1. Original policy or certificate of insurance.
2. Original or copy shipping invoices, together with shipping specification and/or weight notes.
3. Original Bill of Lading and/or other contract of carriage.
4. Survey report or other documentary evidence to show the extent of the loss or damage.
5. Landing account and weight notes at final destination.
6. Correspondence exchanged with the Carriers and other parties regarding their liability for loss or damage.

Applicable Law and Jurisdiction : This policy is governed by and is to be construed in accordance with the laws of Singapore. The court of competent jurisdiction in Singapore shall have the exclusive jurisdiction over all matters relating to the construction, validity and performance of this contract of insurance.
